HAMPTON TOWNSHIP AND SCHOOL DISTRICT TAX INFORMATION

The following information is provided in order to acquaint you with the tax procedures established by the Township of Hampton and Hampton Township School District.

ALL taxes listed below are payable at the Tax Office in Hampton Township. The office is located behind the main building at 3101 McCully Road. The office hours are Monday through Friday, 8:00 A.M. to 4:30 P.M. When making payments, separate checks must be issued for real estate, earned income tax and local service tax. **DO NOT COMBINE REAL ESTATE AND EARNED INCOME TAX PAYMENTS. YOUR CHECK(S) WILL BE RETURNED AND NEW CHECKS WILL NEED TO BE REISSUED.**

I. CURRENT TAXES:

A. REAL ESTATE TAXES: These taxes are to be paid annually based on **100% Market Value** established by Allegheny County. (Prior to 2001 taxes were based on the assessed valuation which was a percentage, 25% in most cases, of the market value set forth by Allegheny County.) Millage rates are set by the Township Council and the School Board.

1. TOWNSHIP REAL ESTATE TAX-PAYABLE TO: TOWNSHIP OF HAMPTON
TOWNSHIP TAXES ARE BASED ON CALENDER YEAR, JANUARY-DECEMBER
BILLED MAY 1; DISCOUNT- DUE JUNE 30; FACE-DUE AUGUST 31; PENALTY-BEGINS 9/1.

2. SCHOOL REAL ESTATE TAX-PAYABLE TO HAMPTON TOWNSHIP SCHOOL DISTRICT
SCHOOL TAXES ARE BASED ON FISCAL YEAR, JULY-JUNE (ie. JULY 2004-JUNE 2005)
BILLED JULY 1, DISCOUNT- DUE AUGUST 31; FACE- DUE OCTOBER 31; PENALTY BEGINS 11/1.

POST MARKS ARE ACCEPTED AND VERIFIED FOR ALL TAX PAYMENTS

****** NOTE: SEPARATE CHECKS MUST BE ISSUED FOR TOWNSHIP AND SCHOOL TAXES. ******
IF ONE CHECK IS SENT FOR TOWNSHIP & SCHOOL TAX, THE CHECK WILL BE RETURNED
AND TWO NEW CHECKS WILL HAVE TO BE REISSUED PROPERLY.

B. EARNED INCOME TAXES: This tax is payable quarterly by all resident wage earners and self-employed individuals regardless of age. This tax is **1% of gross income** and is payable based on your residency in Hampton Township. The revenue collected is shared equally between the Township and the School District.

PLEASE NOTE: IF YOU OR ANY FAMILY MEMBER IS EMPLOYED IN THE CITY PITTSBURGH, IT WOULD BE TO YOUR ADVANTAGE TO NOTIFY YOUR EMPLOYER THAT YOU LIVE IN HAMPTON TOWNSHIP AND ARE LIABLE FOR A 'WAGE TAX' TO HAMPTON TOWNSHIP AND NOT THE CITY.

C. LOCAL SERVICE TAX (LST) (FORMERLY EMERGENCY & MUNICIPAL SERVICE TAX EMST): This tax is assessed to employers with businesses located in Hampton Township and self-employed residents. The tax is **\$52.00 per person per year** and is remitted quarterly by the employer or the self-employed resident to the Township. For specific information, please view the website under taxes for Local Service Tax.

NOTE: THERE IS NO BUSINESS PRIVILEGE TAX IN HAMPTON TOWNSHIP.

II. GENERAL INFORMATION:

Real estate taxes are liened by the Township and School District at the end of each year.
