RESOLUTION NO. 1000

A RESOLUTION OF THE TOWNSHIP OF HAMPTON, A HOME RULE COMMUNITY, SITUATE IN ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING THE TRAFFIC CONTROL AND PARKING REGULATIONS OF THE TOWNSHIP PURSUANT TO SECTION 3 OF ORDINANCE NO. 731 KNOWN AS THE TRAFFIC AND CONTROL ORDINANCE OF THE TOWNSHIP OF HAMPTON.

WHEREAS, the Township of Hampton has determined that certain traffic control and parking regulations should be implemented and adopted per the Traffic and Control Ordinance of the Township of Hampton as set forth in Ordinance No. 731 and Ordinance No. 395, codified in Chapter 296 of the Hampton Code of Ordinances; and

WHEREAS, Ordinance No. 731 specifically provides that the traffic control and parking regulations shall be established by Council via Resolution per Section 3; and

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Township of Hampton as follows:

1. In Chapter 296-2 Definitions, the following definition shall be added:

MOTOR VEHICLES – A vehicle which is self-propelled or a vehicle which is propelled solely by human power. This definition does not include vehicles which are attached to a motor vehicle for transport. Also excluded from this definition are recreational vehicles, motor and/or mobile homes and the like, which are not permitted to park on any Township street.

MOTOR AND/OR MOBILE HOMES – A trailer designed and used for living quarters or commercial purposes.

RECREATIONAL VEHICLES – A trailer and/or vehicle designed or adapted and used for recreational purposes.

2. Only motor vehicles are permitted to be parked on any Township street. This section specifically prohibits the parking of non-motorized vehicles, including but not limited to, boats, trailers, dumpsters or other non-motorized vehicles, with the exception of parking to load and unload items for a limited period of time, not to exceed twelve (12) hours.

3. Motor and/or mobile homes, and recreational vehicles are specifically prohibited from parking on any township street at any time.

4. Section 296-10 Violations and Penalties shall be amended as follows:

Any person who violates any provision of this part may be cited by the issuance of a Hampton Township parking notice violation or through the issuance of a traffic citation under Pennsylvania Vehicle Code, Title 75, Pa.C.S.A. Person(s) issued a Hampton Township parking violation notice shall pay a fine of Twenty-Five (\$25.00) Dollars. It shall be the duty of a police officer issuing a Hampton Township parking notice violation to indicate the provision of this part violated, the license number of the vehicle involved in the violation, the location where such violation took place, the date and time of the violation, and any facts that might be necessary in order to secure understanding of the circumstances attending such violations. The police officer issuing a Hampton Township parking violation notice shall also attach to or place upon the vehicle a notice (including a payment envelope) stating the vehicle was in violation of this part. The notice shall contain instructions to the owner or driver of the vehicle that a fine of Twenty-Five (\$25.00) Dollars must be paid to Hampton Township within ten (10) days. Hampton Township parking violation notices not paid within the ten (10) day period will result in the issuance of a traffic citation under the Pennsylvania Vehicle Code, Title 75, Pa.C.S.

5. The remaining provisions of the Township's Traffic and Control Ordinance, which

do not conflict with the provisions set forth herein, shall remain in full force and effect.
